**1. Name**

The event is of a specialized nature and its title is SICAM 2022, International Exhibition of Components, Semi-finished Products and Accessories for the Furniture Industry.

**2. Venue, dates and times**

The event will take place in the Pordenone Exhibition Centre from 18th to 21st October 2022.

Visitors' access will be from 9.30 a.m. to 6.00 p.m., the halls will be open for exhibitors from 8.30 a.m. to 7.00 p.m.

**3. Participants**

All manufacturers, Italian or not, of products on the Product List are eligible to participate as exhibitors, together with representatives and agents of such manufacturers. Representatives and agents may participate in the Exhibition under their own company name. Also admitted as participants, at the Organizers' entire discretion, are trade press publishers, public bodies, associations, institutes and other manufacturing or trade bodies which are in any way recognized as promoting, supporting or designing (as their main activity) goods connected with or similar to the Exhibition's product categories and in keeping with its characteristics.

**4. Exhibitors' fees**

Companies with foreign VAT numbers are exempt from VAT pursuant to article 7-ter of Presidential Decree no. 633/1972 and subsequent amendments.

This package price includes the right to use the following: exhibition space with modular fittings, strip-lighting false ceiling, wall-to-wall carpet for all hall areas, spot lighting, mains power sockets on request, service bar and restaurant, reception, secretarial service, meeting rooms, press office, advertising, entry in the official catalogue, cloakroom, car parking, security service.

**5. Acceptance of entry terms**

Presentation of the entry application form entails, in addition to meeting the requirements of § 3 above, acceptance of these General Regulations in their entirety, as well as all rules and standards issued subsequently for the Exhibition's organization and functioning.

The full application also constitutes a firm commitment by the applicant to take part in SICAM 2022. Such commitment is valid for thirty days after receipt of the confirmation email from ExpoSicam.

In order for applications to be considered and deemed valid, they shall be filled-in in full, signed and accompanied by a copy of the bank transfer made to pay the 20% deposit as required by articles 6.a) and 7. If the bank transfer date does not coincide with the application date, the former will be considered the effective start date for the purposes of the above thirty-day term. The Organizers will communicate their decision regarding the acceptance or refusal of the participation application within thirty days of receiving the application. Said decision is final and does not have to be justified. In case of denial, the applicant shall not be entitled to any compensation and/or indemnity and/or reimbursement of expenses, without prejudice to their right to reimbursement of the sums already paid as a deposit.

Should insufficient exhibition space be available to meet demand, priority is given by the date the application is received.

**6. Entry Procedure**

For legitimate participation in the Exhibition the following documents must be sent to ExpoSicam Srl, Via Carducci 12, 20123 Milan, Italy:

- a) completed entry application form (all sections), plus copy of bank transfer in payment of the 20% deposit + VAT, made payable to ExpoSicam Srl;
  - b) a copy of the Company Registration certificate (in Italy, Chamber of Commerce Industry Agriculture and Crafts registration certificate).
- For representatives and agents, in addition to the above documentation:
- c) an entry application for each firm represented, all sections completed;
  - d) copy of or extract from the appointment mandate for each individual firm represented.

**7. Payments**

At the time of sending the entry application, proof of payment of the deposit (20% of the whole amount due + VAT if applicable) must also be enclosed: a copy of the bank transfer document, payable to: ExpoSicam Srl

The balance (80% + VAT if applicable) must be paid not later than 20th June 2022, a mandatory deadline.

Should the balance not be paid within such deadline, the contract will be rescinded and the deposit paid will not be reimbursed but instead charged as a penalty, without prejudice to claims for further loss and to the Organizers' option to reassign the exhibition space.

Any applications sent after 20th June 2022 shall be accompanied by full payment plus VAT.

**8. Transfer and cancellation**

The transfer of all or part of the exhibition space, even free of charge, is strictly prohibited.

**9. Allocation of exhibition space**

The exhibition spaces are distributed at the sole discretion of the Organizers, and will take account of the following:

- due completion of the application and payment of the deposit;
- the date of presentation of the application;
- the space available.

The Organizers shall also try, as far as possible and within the limits of availability, and without prejudice to its freedom of choice and the absence of any and all obligation to provide justification, to accommodate the preferences expressed by applicants, but without disregarding the general benefit of the Exhibition on that account; the Organizers reserve the right to change or modify the exhibition space assigned. The participants must observe all safety regulations in force, none excepted. They explicitly relieve the Organizers from all liability with regard to third parties and shall in any case be liable for any damages caused by the non-observance of themselves or of their employees/appointees of the safety regulations, imprudent or improper use of machinery, materials and equipment ensuing to themselves, to the Organizers and to third parties.

**10. Installation**

During the days allocated for installation and dismantling of the stands within the halls, it is strictly forbidden to use any machinery which produces dust, without provision of suitable dust-extraction devices.

The display of any sort of machinery is strictly forbidden.

The Organizers provide stand installation, wall-to-wall floor covering in moquette and a lighted grid ceiling. This ceiling must in no circumstances be altered, manipulated or removed by the exhibitors, nor may it be used as a support for posters, graphic displays or similar purposes. Furthermore, work involving the regulation of the lighting installed on this ceiling and work involving the installation of electrical conductors may only be carried out by the exhibition Organizers' staff. Exhibitors, stand builders and connected personnel violating this regulation are liable for all damages caused.

In exceptional cases, in view of special requirements for product display, the possibility of allowing the use of display components other than those provided by the Organizers will be considered. Requests for such exceptions should be sent to the Organizing Secretariat, to arrive by 1st July 2022, accompanied by a detailed drawing; these requests will be determined at the Organizers' sole discretion.

In no circumstances will any exceptions be allowed to the main or special parameters for the Exhibition, which are as follows:

- the maximum height for any display component is 2.25 m;
- the abutting sides of stands will be equipped preliminary with partition walls. The sides towards passageways will have to be kept predominantly free (minimum 50% of each side);
- the hall flooring is entirely covered by a moquette which has not to be removed or covered in any way;
- the display components have to be self-supporting (borders, frames and ceilings or similar elements are not allowed).

**11. Catalogue**

The Official Exhibition Catalogue will be printed and distributed without engaging the Organizers or the Publisher in any liability. Exhibiting firms will have right to an entry giving company name, company registered office, and code numbers for the products exhibited.

The data published in the Official Exhibition Catalogue are directly registered by the exhibitors on their own responsibility.

The Organizers will also be able to arrange, directly or indirectly, for the production and distribution of other publications of various kinds, and reserve the right to use such publications to illustrate and advertise the Exhibition at any time and in any surroundings, in Italy or elsewhere.

**12. Security**

The Organizers will provide ordinary and general day and night security, while individual exhibitors will be responsible for protecting their own property.

Specifically, the security cover applies to the building as a whole, but does not include the individual stands. If individual exhibitors see the need for specific security for their stands, the Organizers can provide the names of authorized security companies on request so that the exhibitors can reach their own independent agreements therewith.

To the extent of their duties and within the above limits, the Organizers shall only be held liable in the case of gross negligence or willful misconduct, with the burden of proof falling fully on the exhibitor wishing to claim breach of contract.

**13. Insurance**

The individual exhibitors are responsible for any insurance policies they underwrite.

**14. Liability**

The Organizers and the Pordenone Exhibition Centre accept no liability for losses of any kind whatsoever, and in particular shall not be responsible for loss of or damage to the objects exhibited or for loss or damage caused by others, save where grave negligence is proved against the Organizers, the Pordenone Exhibition Centre, or their appointees or of employees. Also in such cases, the burden of proof falls on the exhibitor wishing to claim breach of contract by the Organizers.

The participant will be liable to the Organizers for all damages to things exhibited, to equipment and to people directly or indirectly attributable to the participant, and shall also be liable for whatever the Organizers must pay as compensation and/or indemnity to any third party, without any exceptions or limitations, and, accordingly, undertakes to hold the Organizers harmless.

**15. Prohibitions**

In addition to those already set out in the specific articles, the following general prohibitions apply:

- the sale of products with delivery on the spot is forbidden;
- the display of prices is forbidden;
- no exhibitor, exhibitor's employee, or visitor may remain at the stands or within the perimeter of the Exhibition outside the Exhibition's set hours without special authorization from the Organizing Secretariat;
- no material may be brought into the Exhibition which smells bad, or is in any way hazardous or liable to cause damage, injury or annoyance; this prohibition is in addition to all laws, regulations and special provisions applying to meetings in public places;
- all sound production equipment is forbidden, including radio receivers. The secretariat may use the installed loudspeakers for official announcements of general interest, or in any emergency;
- the trade marks for the Exhibition Centre, the Organizing Secretariat and the Exhibition may not be used without written authorization;
- exhibiting firms are forbidden to have advertisements outside the pavilions or moving in the aisles, streets or neighborhood of the Exhibition District, and the distribution of objects which constitute advertising vehicles is likewise forbidden. No posters concerning competitions or prizes offered by firms, organizations, or by daily, weekly or specialized publications, may be displayed within the exhibition spaces. Contravention of the above rules will lead to penalties in addition to exclusion from the Exhibition in future years.

**16. Promotional activities**

In addition to the obligation of compliance with legal and public safety requirements, promotional activities, distribution of advertising material etc., which may only be conducted within the promoter's own exhibition space, must be such as not to injure, damage, disturb or annoy the other exhibitors or the visitors.

**17. Photography and reproductions**

Stands and exhibited products may not be photographed, filmed, drawn or recorded in any way without the authorization of the exhibitors concerned and of the Organizing Secretariat. The Organizers cannot however be held liable for any contraventions by third parties.

However, the Organizing Secretariat itself reserves the right to record, or to authorize the recording of, general or detailed views, outdoor or indoor, for the purposes of a proper record of the Exhibition.

No photographic or cinematographic equipment may be brought within the perimeter of the Exhibition without the Organizing Secretariat's written permission. A copy of every authorized record must be supplied to the Organizing Secretariat.

**18. Regulation (EU) 2016/679**

(General Data Protection Regulation)

ExpoSicam S.r.l., as Data Controller, will handle your personal data in the way described in the privacy policy available on our website (<http://www.exposicam.it/it/p-700/privacy-policy/>) or at the entrance to the fair, in accordance with art. 13 of GDPR 2016/679.

**19. Amendments to the Regulations**

The Organizers reserves the right to make such rules and standards as they think fit - even in derogation of these General Regulations - for the due regulation of the Exhibition and the services within it (e.g. Exhibitor's Vademecum).

**20. The Organizers' option to suspend the contract**

Should the applicant seriously breach the terms of this General Regulation and any similarly mandatory amendments or integrations thereto, the Organizers have the right to suspend the contract without prior notice, expelling any non-compliant exhibitors from the Exhibition. In such case, the exhibitor shall have no right to reimbursement or indemnity of any kind.

**21. Force majeure**

In the event of force majeure or, in any case, for reasons not due to the Organizers (for example the current pandemic situation linked to Covid-19), the date of the Exhibition may change or the Exhibition itself may even be cancelled. Should the Exhibition be postponed for one of such reasons, the Organizers will not be liable to pay indemnity and/or damages to the exhibitors.

The postponement of the Exhibition shall not lead to termination due to supervening impossibility, unless it is postponed by more than twenty-four months from the date originally set. In this regard, by signing this document, the exhibitor declares their enduring interest in taking part in the Exhibition within the mentioned twenty-four term.

Should the Exhibition be cancelled or postponed by more than twenty-four months for one of the above reasons, this contract shall be considered rescinded due to supervening impossibility and the Organizers shall refund any fees received from the exhibitors, deducted pro quota the expenses that the Organizer incurred into and which remained at his expense.

**22. Complaints**

Any complaints must be made in writing not later than eight 8 days from the discovery of an alleged deficiency or defect(s), and at all events within 8 days of the end of the event.

**23. Waiver to ruling jurisdiction**

The Court of Milan shall have sole jurisdiction and venue over any controversy, with any and all other concurrent Courts excluded, and the Italian text of the General Regulations shall be authoritative.
